- b. Hwy Superintendent Stripped shoulders and ditched on Hardscrabble Road, put new driveway pipe on Greengrass Road and one on Hardscrabble Road. Fixed Harvey Clark's driveway approach due to water running from road. Gravel hauled in for Gosper Road that is currently being laid down. Mowed and trimmed around Town Barn, picked up new cab and chassis from Wester Star. Completed budget papers with the bookkeeper, Regraded the far end of John Rial Road's washboard spots, and spot graveled Fred Rail Road. Fuel log submitted, fuel usage was 305.5 gallons.
